CEES, jointly sponsored by National Energy Administration (NEA), its Department of New and Renewable Energy, National Development and Reform Commission (NDRC), its Department of Resource Conservation and Environment Protection, National Center for Climate Change Strategy and International Cooperation, University of International Business and Economics and State Information Center, has been successfully held for 8 consecutive sessions since 2008. In 2009, the State Council approved the Summit as the 2nd Sub-Forum of the Global Think-Tank Summit. and Former Premier WEN Jiabao, Premier LI Keqiang of the State Council, met with major international guests and delivered a keynote speech.

The 9th CEES is jointly hosted by China Energy and Environment Research Center, China National Renewable Energy Center (CNREC) and Xinhua Net and organized by Consulting Center of CEES in Beijing from December 11th-12th, 2016.

All government officials, decision-makers, global investors, senior advisors and technical/financial experts concerned with the fore-said topics and activities are sincerely welcome to participate in the Summit and to work together, and specialists concerned are welcome to contribute to and promote the development of CEES, thus to promote green development and eliminate smog in China and around the world with joint efforts.
